3. Ordinance No. 348-2025: Amending Central Business Zoning–Signage – 1st Reading – Purcell
 - a. Mayor Purcell introduced this 1st Reading of Ordinance No. 348-2025
 - i. Purcell: The 2nd Reading will be done at the next meeting.
4. Ordinance No. 349-2025: Amending Central Business Zoning–Short Term Rentals – 1st Reading – Purcell
 - a. Mayor Purcell introduced this 1st Reading of Ordinance No. 349-2025
 - i. Discussion:
 1. Dusing: I just read the entire CBD zoning ordinance in full.
 - a. We have many issues within this zoning:
 - i. No setbacks are listed.
 - ii. Just a list of about 30 businesses that are allowed.
 - iii. Do we need parking requirements? Currently CBD does not have parking in the zoning.
 - b. I believe we need to modify the zoning to bring in the required details.
 2. Bohman: I agree with Joe that we need to work through the zoning.
 3. Saylor: Are we looking to update the zoning in general or are we moving forward w/ the STR addition?
 - a. Purcell: This topic is the first reading of Ordinance 349-2025. Any further changes must be in writing through a modified ordinance or a new ordinance.
 4. Newman: I agree with Joe we need to modify the zoning.
 - ii. Purcell: 2nd Reading will be done at the next meeting.
